SCOPE OF SERVICES/WORK

The Scope of Services/Work to be provided in this Contract is of multi-disciplinary nature and includes broadly but is not limited to:

1. Interior Construction Works with Procurement & fixing of Interior Fittings & Propriety items.
2. Engineering Construction Works.
3. Specialized Services Construction Works covering:
 - i) Security and access control system
 - ii) Materials, equipment & services for works related to Extra Low Voltage including security, structured cabling, Audio, ITV, PABX, ICT, data, CCTV, Intercom, GCS, data center, HOS/PMS, POS, DECT, BMS, BEMS and Building access control/Automation etc.
 - iii) Integration/Coordination with other multi-disciplinary contractors for Connectivity with Core Building Management System.
