The Contractor's responsibility is to design the power supply up to the northern boundary of the corridor so as to allow RAECO to connect from their sub-station.</p>

Line items shall not be added to Appendix D. Appendix A shall be the total bid price, including all items required even if they are not itemized in Appendix D.
