However, there is a condition refer to the Omanization on page #13 Item 24 of the Prime Document that the Contractor should hire at least 30% of Omani labors. Please clarify the discrepancy for the Omanization.	It is 10%. Page No. 13 (R-1) is being issued through Adden- dum No. 2.
4	Is there a minimum requirement of the score of the Technical Proposal which leads the Financial Proposal to be opened for evaluation?	There is no minimum requirement of score for qualifying Technical Evaluation.
5	Regarding the Prime Document page #13 Item 23, we could find that the original set and two copies of the Tender Documents and Technical Proposal are required, but couldn't make sure of making copies of Financial Proposal. Should two copies of Financial Proposal also be submitted with the original set?	Yes. Copies of Financial Proposal should also be prepared and packed as per procedure described for Technical Proposal.
6	Concerning the elements and evaluation criteria for Financial Proposal specified in the Prime Document page #18, we could figure out that Audited Financial Reports shall be the ground for Evaluation Item F2. In this regard, should the Audited Financial Reports be included in our Financial Proposal with our Bid Price?	Yes.
