Editorial

Permanent investment destinations

The first quarter of this year witnessed a remarkable development in the Special Economic Zone at Duqm and the free zones in Sohar, Salalah and Al Mazunah in terms of completing infrastructure works, attracting investments and strengthening relations with investors. Perhaps, the most prominent of these works is completing the gas delivery project to the Special Economic Zone at Duqm. This paved the way for connecting the integrated power and water plant in Duqm, operated by Marafiq, Centralised Utilities Company, to the gas network, to start soft opening of its operations.

While expressing our profound thanks and appreciation to OQ, one of our key partners in the Special Economic Zone at Duqm for marking the milestone of gas delivery project to Duqm, we are urging investors, wishing to establish projects that require gas, to submit their applications to the Zone.

In Sohar Free Zone, the first quarter saw the opening of the first plant in Qabas Sohar Solar Energy Project with a capacity of 25 MW. This project stands as one of the renewable energy projects that the Public Authority for Special Economic Zones and Free Zones (OPAZ) focuses on, in line with Oman Vision 2040, which targets increasing energy from non-traditional resources.

In regards to attracting investments, the Special Economic Zone at Duqm (SEZAD) and the free zones in Al Mazunah, Salalah and Sohar observed the signing of usufruct agreements to establish new projects with local and foreign investments that add value to the national economy.

The Public Authority for Special Economic Zones and Free Zones (OPAZ) works to promote these zones and shed light on the major investment opportunities available. Reflecting on the different efforts of OPAZ in this regard, Duqm Economist Magazine accords a special portfolio in this issue featuring Al Mazunah Free Zone. There are many investment opportunities on offer in the Zone, which we urge investors to explore; underlining OPAZ vision of making the special economic zones and free zones permanent investment destinations.

The Small and Medium Enterprises (SMEs) stand as one of the areas of investment in the special economic zones and free zones. Thus, they have been accorded a commendable attention and significance by OPAZ like all other big projects. Launching first plant in Sohar Solar QABAS PROJECT

Sohar – Dugmi.

Oman Shell launched, on January 21,2021, the 25-megawatt Qabas solar plant, helping the port and freezone in Sohar to become more sustainable and demonstrating the commercial benefits of solar power for industrial purposes. Owned by Shell, Sohar Solar Qabas is the company's first utility scale, photovoltaic (PV) solar project in the Middle East and in Oman.

An Important step

His Excellency Dr. Ali bin Masoud Al Sunaidy, Chairman of The Public Authority for Special Economic Zones and Free Zones (OPAZ) commented, "Inaugurating this solar project marks the first step for the Public Authority of Special Economic Zones and Free Zones' plan for solar projects. Such projects will help free up natural gas for other industrial use."

50-hectare

The plant is located on a 50-hectare site within Sohar Freezone, northern Oman, and

consists of over 88,000 solar modules. The renewable electricity output from Qabas is supplied to a large ferrochrome production facility, displacing the equivalent gas-fired power generation taken from the grid and avoiding more than 25,000 tonnes of CO₂ emissions annually.

Future ambitions

Walid Hadi, Oman Shell's VP & Country Chairman commented: "This is an incredible project and the first of its kind for Shell in the Middle East and in Oman, while being in line with our ambition to become a netzero emission energy business by 2050 or sooner."

The project was completed to budget and on time while meeting Oman Shell's stringent Goal Zero safety standards. It was accomplished despite unprecedented challenges created by the global COVID-19 pandemic. Oman Shell has future ambitions to facilitate solar energy development within The Sultanate. The plant is located on a 50-hectare and consists of over 88,000 solar modules

The project is the company's first industrial scale solar project in the Middle East and Oman

Allocating a site for the uses of modern technologies and artificial intelligence الدقم Duqm – المعنية :

The Board of Directors of the Public Authority for Special Economic Zones and Free Zones (OPAZ) held its first meeting for the year 2021, chaired by HE Dr. Ali bin Masoud Al Sunaidy, Board Chairman.

During the meeting, held in the Special Economic Zone at Duqm (SEZAD), the Board of Directors touched on the progress made over the past few months in regards to urging local and international companies to localise investments of producing clean energy in SEZAD, through two potential projects for producing green hydrogen and another in Sohar Free Zone, Sohar Solar Energy Project.

Eng. Yahya bin Khamis Al Zadjali, In-Charge of Managing Operations of the Special Economic Zone at Duqm (SEZAD), explained that the Board approved the allocation of two sites in the Special Economic Zone at Duqm for gas-based industries. These sites include the first block, covering an area of 11.1 square kilometres and the second block with an area of 33.5 square kilometres. In

view of this, the Board called on all local and international companies, which are interested to invest in the Zone and require gas for operations, to submit their studies related to their requests to provide gas in Duqm upon the completion of gas pipeline.

Moreover, Al Zadjali noted that the Board initially approved allocating a site for the uses of modern technologies including artificial intelligence such as drone experiments. The Board also directed the Zone's Management to complete studies regarding technical and legal aspects, and to assess the required Internet speed and initial cost to attract local and foreign companies interested in developing future technologies.

Furthermore, the Board of Directors of the Public Authority for Special Economic Zones and Free Zones (OPAZ) paid a visit to the two sites designated for the gas-dependent industries and other existing projects in SEZAD to get familiarised with the latest progress.

Providing training opportunities for undergraduates and vocational colleges students

The Ministry of Higher Education, Research and Innovation and the Public Authority for Special Economic Zones and Free Zones (OPAZ) signed, on February 2021,22, a Cooperation Programme to align higher education, research and innovation with current and future plans of the special economic and free zones in the Sultanate.

The agreement was signed by HE Dr. Rahma bint Ibrahim Al Mahrouqi, Minister of Higher Education, Research and Innovation, and HE Dr. Ali bin Masoud Al Sunaidy, Chairman of the Public Authority for Special Economic Zones and Free Zones.

Under this agreement, OPAZ provides data on economic activities and companies operating in all zones, requirement, challenges and future plans for growth of the labour market, and expected numbers of jobs in coordination with the Ministry of Labour. It also offers training opportunities for undergraduates and vocational colleges students, so the Higher Education Ministry works on a framework for these opportunities.

Supporting innovation and entrepreneurial ideas The Ministry of Higher Education, Research and Innovation coordinates with higher education institutions to provide research and guidance services to OPAZ. Also, both parties establish official channels and mechanisms to support innovation and creative entrepreneurial ideas, which could be turned into companies or commercial projects.

They also urge companies based in all zones to offer scholarships for students to proceed their higher education.

Establishing scientific complexes and cities

The Ministry and OPAZ will encourage private institutions and companies to establish scientific complexes and cities for higher education and centres for scientific research, innovation and vocational training. As well, OPAZ provides incentives, exemptions and determines the usufruct rights for the lands required for such projects, according to the relevant regulations and procedures.

Additionally, the two parties enhance industrial development, promote entrepreneurship and create connections between higher education institutions and industrial establishments to transfer new ideas, business projects and technology to the industrial sectors.

The Public Authority for Special Economic Zones and Free Zones (OPAZ) and the Authority of Small and Medium Enterprises Development signed, on March 23,2021, a Cooperation Programme to promote the role of entrepreneurship in the special economic and free zones. The Programme serves as a platform introducing small and medium enterprises to the business opportunities in these zones.

The agreement was signed by HE Eng. Ahmed bin Hassan Al Dheeb, Deputy Chairman of the Public Authority for Special Economic Zones and Free Zones and HE Halima bint Rashid Al Zaria, Chairperson of Authority of Small and Medium Enterprises Development.

The Programme aims to benefit from the expertise of the Authority of Small and Medium Enterprises Development in developing entrepreneurship in the special economic and free zones. It intends to utilise the powers of OPAZ to overcome the potential challenges of SMEs in all zones.

Specialised platform

The Programme plans to establish a platform for creating innovative projects from

large projects. It recommends opening a service outlet in OPAZ Headquarter, serving entrepreneurs to benefit from opportunities offered by the zones.

Likewise, this cooperation programme endorses conducting a joint study on the Sultanate's markets to find out the supply, demand and gaps. Both Authorities will jointly observe the imported products and materials from overseas, each according to its competences.

Accordingly, they will work on creating investment opportunities, serving SMEs by establishing factories in the zones to produce these imported products and materials. In addition, they will provide business opportunities for projects from construction phase to starting operations.

Providing consultation and supervision services

This Programme includes providing consultation, supervision and training services to SMEs. It, also, allows benefiting from events and exhibitions organised for SMEs in the different governorates, and establishing incubators, accelerators and business centres too.

An integrated city for bus manufacturing

CEO of Karwa Motors speaks to 🕬: Ready to produce the first bus promoting "Made in Oman"

As you pass the main gate, getting inside the bus assembly factory, which is being developed by Karwa Motors in the Special Economic Zone at Duqm, you feel as if you are already in an integrated city for bus manufacturing and not just an ordinary factory.

The factory is being established through a strategic partnership between the Sultanate and Qatar, represented by Oman Investment Authority, owning a 30% share and Mowasalat Qatar, with a share of 70%. During the project's groundbreaking, both parties announced that the total investment would be about \$70 million in the first phase of the project, which could potentially become a destination for bus manufacturing in Duqm in the long-term.

By the time of conducting this interview, in the last week of February 2021, with Dr.

Ibrahim bin Ali Al Balushi, CEO of Karwa Motors, at the company's premises in Duqm, the construction progress rate had reached %95. The manufacturing equipment have already arrived and fixed at the factory, with the Company is expecting the arrival of the raw materials and bus structures through Duqm Port by March 18,2021.

Completed works

During the interview, Dr. Ibrahim Al Balushi was optimistic about the Company's ability to meet the deadline, which had been set earlier so the factory would start the initial production phase before mid-April 2021. Therefore, everything in the factory was proving this right as workers and project's engineers are sparing no effort on the different facilities of the project. The administration building was almost ready, parking area is completed too and the bus





manufacturing and assembly workshops are ready to start work, while the bus inspection yard is ready as well to test the first bus manufactured in Duqm.

Business cycle

When the raw materials and bus structures arrive from overseas, they are initially stored in a large warehouse to be passing three workshops afterward, which are the cutting and welding workshop, the dyeing workshop, and then the equipment and motors assembly workshop. When the engineers confirm readiness of the bus, its capability would be tested in the designated inspection yard. The project site also includes a repair workshop, a secondary power station, a refrigeration equipment room, a fuel station, in addition to the administration building and other facilities.

Producing 200 buses

According to the Karwa Motor's CEO, the Company plans to produce 200 buses during this year for FIFA World Cup 2022. The aforementioned buses will be of the advanced school buses, but the Company will, later on, start producing city buses and long-line buses. The production capacity of the factory during the first phase is 500 buses annually, but post this phase the production range will be from 500 to 700 buses.

40 work stations

The production of the new bus branded as "Karwa" and promoting "Made in the Sultanate of Oman" is not an easy matter at all. Dr. Ibrahim Al Balushi pointed out that the Company has prepared 40 internal work stations, in which workers form and manufacture the buses, install its various parts, paint and check its quality. "Everyone will work in the teamwork spirit to produce distinguished buses that are able to run on various roads and withstand the harshest weather conditions", commented Al Balushi.

Diverse international expertise

In the bus-manufacturing city, if we can call it so, expertise from different countries are gathered to manufacture and assemble new buses. According to the Company's plan, strategic relationships have already been built with the original suppliers and strategic partners to sustain the Company's business and obtain the best raw materials

Coordinating with the concerned authorities in the Sultanate to attract the best local cadres and technologies in the field of bus manufacturing.

Karwa Motors announced previously that it had chosen the well-known Chinese "Higer" Company in the field of bus manufacturing to be Karwa's technology partner and a supplier of tools and equipment for this project.

Higer is known as one of the fastest growing brands worldwide in the field of manufacturing high quality buses, supported by its high innovative capacity and its provision of the best safety standards and high reliability.

Qualifying local cadres

As far as its focus is on the production cycle, Karwa Motors considers its workforce as the real strength of the Company. Dr. Ibrahim Al Balushi noted that the Company has developed a clear training plan to qualify employees to work in the bus-manufacturing industry. Likewise, in coordination with the concerned authorities in the Sultanate, local cadres will be attracted to work in the Company and will be trained in the various phases of work in the field of manufacturing and assembly of buses.

It is expected that the Company will have about 300 employees, but the number will be doubled with the expansion of the Company's business and the increase in production lines.

Economic gains

The project will contribute to thriving the economic traffic in the Special Economic Zone at Duqm by using the facilities of Duqm Port and other ports of the Sultanate to import spare parts, bus chassis and other raw materials and export buses. The Karwa Motors and its products will also contribute to promoting many other economic sectors, especially with regard to public services and shipping companies.

The Port of Duqm, located on the international shipping lines of Karwa Motors factory, provides easy access to international markets in Asia and Africa. Besides, the simple access to the Port ensures that suppliers reach their shipments of spare parts as quickly as possible.

SOHAR signs agreement for the development of ceramic tiles manufacturing facility

SOHAR Port and Freezone entered into an agreement with Eagle Ceramics FZC LLC on January 26,2021. The signing took place at the office of the Public Authority for Special Economic Zones and Free Zones (OPAZ), under the patronage of HE Eng. Ahmed Hassan Al Dheeb, Deputy Chairman of OPAZ. The agreement was signed between Omar bin Mahmood Al Mahrizi, CEO of SOHAR Freezone – DCEO of SOHAR Port and Manoj Valamji Panchotiya, Partner at Eagle Ceramics FZC LLC. The partnership will see the establishment of ceramic tiles manufacturing facility at SOHAR Freezone.

Increasing zone's attractiveness

Commenting on the upcoming facility, Omar Al Mahrizi stated, "We believe that the introduction of the new ceramic manufacturing facility will enhance the offerings of the Freezone, especially with regard to ceramic products. Apart from generating value-added services, the project is in line with our overall objective to increase the attractiveness of SOHAR Freezone to regional and global investors. This, in turn, will allow us to boost our contribution to the GDP of the Sultanate and further the development of the logistics sector, alongside the creation of several job opportunities in the long-run."

Capital investment

The project will see an estimated total capital investment of USD 1.2 million and will take up a plot size of 20,000 m2 at SOHAR Freezone. The finished products from the facility will be distributed locally as well as exported regional GCC markets.

Manoj Valamji Panchotiya added, "We are proud to set up our new facility at SOHAR and are keen on being a part of the growing complex. We also look forward to the establishment of further downstream projects in the future, to enhance the offerings at SOHAR, alongside other industries. We believe that the ceramics facility will contribute towards the nation's efforts of economic diversification by promoting the export of ceramic products into the region and beyond." Managing development of 6 new infrastructure projects

Company's success attracts corporates operating in SEZAD to offer facilities management services

Oman Company for the Development of Special Economic Zone at Duqm "Tatweer Dugm" has developed (46) projects in the field of infrastructure and consultancy in the Special Economic Zone at Duqm (SEZAD). Among these projects are Wadi Say Dam, Wadi Jarf Dam, canals for draining rainwater from dams to the sea, the second, third, fourth and seventh packages of the Duqm Port, which comprise the Commercial Berth, Government Berth, and the Liquid Berth. Additionally, Tatweer worked on other key projects including the buildings for operating the Port of Duqm, Customs Station, multipurpose Fishing Port and the Headquarter of SEZAD, in addition to the 150 residential units built for the people of Duqm and many other projects too.

Infrastructure projects

The number of current projects supervised by Tatweer is (6) infrastructure projects, including construction of Roads 1 and 5, drainage systems at Duqm Port, dualisation of Sultan Said bin Taimur Road, Fishing Port (marine and road related works), water distribution network expansion, construction of store and control room and design and construction of sewage water plant in Duqm.

Assets and facilities management

Tatweer Company oversees the operators of strategic assets in SEZAD, including Duqm Port, Duqm Airport and Drydock facilities, as well as operating and maintaining others that are roads and their facilities such as lighting, traffic lights, signboards, owned and rented buildings. In addition, it also operates sewage plants, dams and canals.

Tatweer in 2014 by (OPAZ) is aimed to ensure the efficient management and implementation of all projects to develop SEZAD. As well, it is intended to manage the various assets within the Zone in accordance with the regulations in place regarding quality and HSE. In addition, it serves to invest in business opportunities that focus on the development of Duqm while at the same time maximise shareholders' returns.

Honing skills of Omani engineers

Over the past years, Tatweer has been able to build a highly skilled team of Omani engineers.





This has empowered the Company with ample experience in projects development, assets management and attracting investments that open opportunities to get into new projects outside SEZAD boundaries.

Expanding facilities management

It is expected that the Company will achieve greater growth during the coming years in assets management, thanks to its experience of developing many infrastructure projects in Duqm over the past few years. Duqm Economist Magazine realised that Tatweer will focus, in managing the assets, on reducing operating costs and increasing the lifespan of assets. Facilities Management opens the door to meet the need of other companies based in Duqm to provide them with facilities management services.

Tatweer's experience in facility management has led the Company to change its approach from complete outsourcing to an in-house approach to manage the facilities. This has been achieved through in-house capacity building strategy, as every facility in Duqm is now directly managed by Tatweer. This approach has contributed to saving huge sums to OPAZ, while similarly it has assisted in developing human capabilities in Tatweer.

Investment management

In regards to investment management, Tatweer played a big role in attracting

investors by entering into partnerships in small proportions. Hence, this approach contributed to increasing investors' confidence in Duqm.

During the last period, the Company succeeded in establishing three companies whose share in the capital ranged between 15% and 70%. Last February, it gave up its share in Duqm Quarries Company to achieve an investment return of 33%.

Through its previous experience, Tatweer could stand as a strategic partner for any investor, wishing to partner and get supported or provided with any technical support to manage projects, assets and facilities.

Omanisation and social responsibility

By the end of 2020, the Omanisation rate of Tatweer Company reached about 88%. The Company remarked that Omanisation is one of its most important national objectives striving to achieve by attracting, training and qualifying national cadres to undertake leadership positions.

Moreover, Tatweer has also contributed to achieving many gains in Corporate Social Responsibility (CSR). The Company joins other founding members of Tawasul Charitable Foundation, which was established by (OPAZ) in Duqm. As a historical milestone, the first quarter of this year witnessed the start of flowing natural gas to the Special Economic Zone at Duqm (SEZAD). The Integrated Electricity and Water Plant received the first flow of gas that was pumped from the assembly and treatment plant, located about 10 kilometres from Duqm Refinery.

Mansoor bin Ali Al Abdali, Vice President of Gas Network Operations at OQ, expressed his delight for making this milestone, reflecting the Government's commitment to provide the key infrastructure to attract heavy industries to Duqm. He also stressed that the gas supply to Duqm is a commendable addition to the 4,000 gas pipeline network that the Company runs in the Sultanate, providing energy and industrial projects with their needs of gas.

In an exclusive interview with Duqm Economist, Al Abdali said that the OMR

98-million gas delivery project in Duqm is aimed to meet the current and future needs of gas supplies for the projects in SEZAD and will encourage manufacturing industries to invest in the Zone.

Project's components

He explained that the project consists of 4 key parts; The First is the gas facilities in Sih Nahida, where the pipeline has been connected to gas sources from the producing companies. The length of the pipeline, extending from Saih Nahida to Duqm is about 220 km with a volume of 36 inches and its capacity is 25 million cubic metres of gas per day. The Second Part is the assembly and treatment plant, which is located in the Special Economic Zone at Duqm (SEZAD), including 4 separate locomotives in which gas is treated and purified. Each locomotive has a capacity of 5 million cubic metres per







day and through these locomotives, gas is pumped into the distribution lines, which mark The Third Part of the project.

Al Abdali commented that so far two distribution lines have been established; one to Duqm Refinery with a capacity of 32 inches and the other to Marafiq Company with a capacity of 18 inches. He also confirmed the project's ability to establish new lines to supply gas to new projects. "As for the Fourth Part, it is the staff building and maintenance workshops located near the assembly station in Duqm. On the other hand, employees have started their work at the site, with the project's Omanisation rate reached 100%" added Al Abdali.

Moreover, he touched on the amount of gas that will be pumped to Duqm, explaining that the gas supply station will receive 15 million cubic metres of gas per day in the first phase of the project. However, the station is prepared to increase its capacity to 25 million cubic metres per day whenever the need arises and as per growth that SEZAD will witness in the future.

The first gas consumer

He pointed out that the Company had started operating the gas pipeline to Duqm in December 2020, while the station was operational in February, and in March 2021, the gas was pumped to the first consumer, the Centralised Utilities Company, Marafiq.

Efforts and challenges

Commenting on the Company's efforts to deliver gas to Duqm, Mansoor bin Ali Al Abdali, Vice President of the Gas Network Operations at OQ, said, "The project was launched in 2017, and the Company accorded a great attention and capabilities to the project. For instance, the project's path passed through various terrains such as mountains and swampy lands. In the mountainous locations, there was a need to use explosives to construct the route for the pipeline, while in the swampy areas the ground had to be leveled and changing the soil, so it becomes solid to facilitate transporting the equipment to the project and placing the pipe in a safe place".

"The number of workers in the project reached 1600, and the Company was able to accomplish more than 5 million hours of work during the project implementation period" He explained.

Supporting local industries

In a closing note, Al Abdali commended the project's support for local industries and In-Country Vale. "More than 19,000 tubes were packaged locally in the pipes factory in Sohar, and then transported by land to the construction site through more than 3,800 trucks in a record period of time", He remarked.

Supplying the Refinery with power and water according to the schedule agreed upon this year Marafiq (Centralized Utilities Company) has started the commissioning activities of the integrated power and water plant in the Special Economic Zone at Duqm (SEZAD), post receiving the first batches of natural gas designated for its operations.

The plant is part of an integrated complex implemented by Marafiq in SEZAD, bringing a 326 MW power generation plant, a 36,000 cubic metres per day water desalination plant and seawater intake facilities with a supply capacity of 1.5 million cubic metres daily. In addition, a 132-kv high-voltage electricity transmission line was constructed from the 326 MW power plant to Ras Markaz oil tanks project, located approximately 80 km far from the Heavy Industries Zone in SEZAD.

Marafiq is a joint venture - owned by OQ, a subsidiary of the Oman Investment Authority, and Gulf Energy Development Corporation of Thailand. Marafiq is actively working on developing the utilities sector in Duqm under the Central Utilities Services Agreement with SEZAD. Marafiq has established a subsidiary company, Duqm Power Company to implement Duqm Integrated Electricity and Water Project and a 132-kv high voltage electricity transmission line project.

Marafiq's management to understand the Company's progress, future planning of its involvement in SEZAD and other projects contributing to developing various heavy industries in Duqm.

An important milestone for SEZAD

Abdullah bin Mohammed Al Hashimi, Project Director of Marafiq, expressed that "Marafiq" is the first company to receive natural gas in Duqm, stressing that the arrival of natural gas is an important achievement for the Zone. All preparations and precautions for the natural gas receiving stations and gas pressure rebalancing station were completed. Then, permission was granted to start receiving gas, feeding the gas turbines, commencing the commissioning activities.





Completing 90% of the project

Abdullah Al Hashimi stated, "Marafiq completed approximately 90% of its strategic project in Duqm by end of last March, and recorded over than 6.3 million safe working hours without Lost-Time Injuries (LTI).

All the 5 gas turbines have been installed in addition to 5 steam turbines at the site. Additionally, the marine works for the seawater intake facilities is experiencing significant progress, as is the construction of water and fuel storage tanks that are close to completion. It is expected that the plant will be able to supply OQ8 (Duqm Refinery) with power and water according to the schedule agreed upon this year.

Power transmission line to Ras Markaz

Marafig built а 132-kv electricity transmission system to provide electricity for Raz Markaz based OMAN TANK TERMINAL COMPANY (OTTCO). The project comprises constructing approximately 80 km of overhead lines from Duqm to Ras Markaz, 240 towers and a 33/132 kv substation. All engineering and construction works on the project are completed and only the final connection remains, recording more than one million working hours without Lost Time Injuries (LTI).

Negotiation with "Tanweer"

Hamed Al Wahibi, Marafiq's General Manager of Business Development, stated: "Negotiations started with Tanweer at the end of 2019 to provide a portable gas operated 80-MW power station. Marafiq plans to build and operate the station for 3 years with an option to extend for a fourth year. By then, SEZAD will be connected to the Sultanate's main grid of 400 KV of high

voltage. The commercial operation of the new plant will start 6 months after signing the power purchase agreement".

Economic and environmental gains

"The new plant will achieve significant savings for Tanweer in energy costs, as a difference in cost between the currently used diesel and the gas station that Marafiq will provide. Consequently, the cost of producing one megawatt will be significantly lower than the current cost, and will reduce government subsidies, in addition to sustaining power supply and reducing greenhouse gas emissions", Al Wahibi explained.

Drinking water sector

Abdullah Al Hashimi noted, "In 2019 the Public Authority of Water "Diam", provided Marafiq with a 25-year license to produce, distribute and provide potable water services in SEZAD. In November 2020, Diam operations and assets were transferred under license to Marafiq, as the sole producer and distributor of potable water in SEZAD".

addition to expanding the distribution network, improving the quality of customer services, and connecting new subscribers to the network", He explained.

Operating and Maintenance

"Marafiq is working to become a leading and professional company in providing operations and maintenance services for different facilities in Oman and a recognised centre for excellence in operation and maintaining facilities", Eng. Abdullah bin Khalfan Al Farsi, Senior Manager of Operation and Maintenance commented.

"Post signing the partnership between OQ and Gulf Energy Development Company, the operation and maintenance strategy has been shifted from "using an external operator" to "using internal and trained cadres". This is made achievable by the significant experience of the Marafiq's strategic partner in developing, operating, maintaining and managing power plants", He added.

Moreover, an integrated operation and maintenance team was formed during the pre-operation phase of the project. This is aimed at developing the appropriate expertise and a competitive operation and maintenance team.

SMEs development

Al Farsi stated, Marafiq is working with OPAZ to reach the best strategy, compatible with the private sector and other employee welfare activities. The number of employees in operation and maintenance facilities is about 60 people, with anticipation to rise up to 100 with the high potential demand.

The Company will also rely on SMEs in IT, communications and data hosting. Therefore, power and water plants and other facilities

will be connected locally, and through a platform with the headquarters, and there will be a need for data storage and information security.

It has a training plan for employees focusing on HSE, environment, quality, time management, supervision and leadership skills", Nasser Al Habsi, Senior HR Manager explained.

In 1992, when the borders between the Sultanate and the Republic of Yemen was demarcated, there was no people living there, which afterward became the Wilayat of Al Mazunah.

The Wilayat of Al Mazunah is one of the ten wilayats of Dhofar Governorate, located about 260 km away from Salalah and 1125 km away from the Governorate of Muscat. It can be reached through Muscat – Salalah Road by turning right after the second roundabout in the Wilayat of Thumrait. Al Mazunah is around 19 km away from Thumrait.

The road to Al Mazunah was quiet and peaceful, despite having many trucks crossing the road. Drivers could stop for a while on the way at Niyabat Moudi in the Wilayat of Thumrait to have a rest before continuing to Al Mazunah.

Al Mazunah is distinguished by its strategic location on the Omani - Yemeni borders, standing as the Gulf gateway for the transit trade to the Republic of Yemen. Establishing the free zone in Al Mazunah came as a testament of the distinguished relations between the two countries in a way that contributes to the recovery of the economy on both sides of the borders.

In this profile, the editorial team of Duqm Economist Magazine seeks to introduce the readers to the free zone in Al Mazunah in terms of growth and available investment opportunities. Al Mazunah was just a barren desert before it experiences aspects of the blessed renaissance, turning it into a prosperous city. Today, it hosts all government services, diverse economic activities, two branches of local banks and a number of hotel apartments, in addition to shops, restaurants and cafes, which witness an active business and turn out throughout the week.

Sheikh Musallam Mohammed bin Zabanoot, Deputy Wali of Al Mazunah, highly commended the comprehensive development and renaissance witnessed in the Wilayat. In an interview with Dugm Economist Magazine, he stated, "The late His Majesty Sultan Qaboos bin Said - May Allah rest his soul in peace - was the one who named the Wilayat of Al Mazunah after the boarders' demarcation between Oman and Yemen. At that time, there were no people living here, but Omanis were residing in the Niyabat of Shehn, which belonged to the Sultanate before the demarcation of borders".

"Post the demarcation in 1992, those Omanis moved to this current location in 1996, which afterward had been called by the late Sultan "Al Mazunah". This name reflects his aspiring for the would be future prosperous city. Al Mazunah remained as Niyabat affiliated with the office of the Minister of State and Governor of Dhofar until 2006 when the Royal Decree No. 2006/13 was issued to upgrade the administrative level of Al Mazunah to be Wilayat" The Deputy Wali explained.

Development services

He pointed out that the Wilayat of Mazunah is among the largest wilayats in terms of population density in the desert areas of the Dhofar Governorate. According to 2020 electronic census, its population reached about 8,400 people, ranking fifth in terms of population in the Dhofar Governorate, which includes 10 Wilayats. Omanis mark %86.9 of the total population in the Wilayat of Al Mazunah.

in Al Mazunah, the Deputy Wali stated, "Al Mazunah, which is about 260 km from the city of Salalah, has received various government services, especially in the field of education, health, municipal and housing services. Last year, the Tender Board awarded a project to establish a hospital in the Wilayat of Al Mazunah at a cost of OMR 15.3 million, standing as a new addition to the healthcare services in the Wilayat. In the education front, there are 9 government schools and a private school. The Wilayat and its affiliated Niyabats have also witnessed the distribution of about 632 houses granted by the Government to Omanis".

Economic boom

The Deputy Wali of Al Mazunah confirmed that the establishment of the free zone in Al Mazunah contributed to the economic recovery of the Wilayat. Trade traffic between the Sultanate and Yemen passes through this free zone and many investors, traders and truck owners stop in Al Mazunah before heading to Yemen or the other Wilayats of the Sultanate. This has contributed to an increase in the demand for utilities, hotels and restrooms as well as caused a recovery of other economic sectors. He also stressed that the locals at Al Mazunah depend a lot on Al Mazunah Free Zone to attract investments and provide more job opportunities.

"We have high aspirations for an increase of economic activity more than what is currently being witnessed in light of the future plans of Oman Vision 2040, thanks to the visionary leader His Majesty Sultan Haitham bin Tarik", addressed the Deputy Wali of Al Mazunah.

Economic and tourist factors

Sheikh Musallam bin Mohammed Zabanoot, Deputy Wali of Al Mazunah, highlighted the different economic and tourist components of the Wilayat, which includes 3 Niyabats: Harweeb, Tusnat, and Metin, in addition to Citizens depend a lot on the free zone to attract investment and provide more job opportunities

the Andat Centre and Hebrout Triangle, in which the historic Hebrout Castle is located. As well, there are people living in a place called Hurut, located in the southeast from the centre of the Wilayat and there is an archaeological site called Musanin.

Each Niyabat is characterised by a number of competitive advantages; Harweeb, for instance, is distinguished by having a number of water springs and Wadi Harweeb, which is linked to Wadi Aidem, one of the largest valleys in Dhofar Governorate. However, Tusnat is a pastoral area in which valleys are abundant, while Mitten is famous for its location on the outskirts of the Empty Quarter Desert and covered mostly by sand dunes and is known for Ramla Jadela, whose height is 455 metres above the sea level.

This site has attracted many tourists from within and outside the Sultanate inside and outside the Sultanate. Recently, a number of archaeological remnants, dating back to the ancient times of humanity, have been discovered there, according to the specialists. The Wilayat of Al Mazunah is also home for many other tourist attractions, such as Shrout Rock, a prominent geological and historical landmark.

Plains and green lush

The Deputy Wali of Al Mazunah, pointed out that the topographic diversity of the Al Mazunah, including mountains, valleys, sand dunes and vast plains, introduced different potentials for investment. The Wilayat is famous for having rich animal wealth, especially camels and sheep, and it is characterised by rich fertile plains that are good for farming. In this regard, he referred to the experience of a citizen in establishing a model farm full of different vegetables, fruits and date palms. This indicates that Al Mazunah is good for planting all kinds of crops.

Shrout Rock stands out in the Wilayat of Al Mazunah as one of the most important tourist, archaeological, geological and historical landmarks. The Rock was known in the past as a meeting place for camel caravans crossing the region and where tribes used to hold their meetings under its shade.

The Rock is still of high significance to the people of Al Mazunah for it is considered one of the meeting hubs there, witnessing different events and functions, including weddings.

The Rock, which is about 6 km away from the centre of Al Mazunah, is distinguished by its wide, round body. In view of that, it can be seen from a long distance due to its location in the middle of a flat ground.

Said bin Abdullah Al Balushi, Director General of Al Mazunah Free Zone, confirmed that the Zone's future plan focuses on attracting international investors, strengthening partnership with Yemeni investors and establishing projects in the field of storing re-exported goods. The plan also includes implementing the fourth development phase with an area of 4 million sqm, bringing a diverse group of economic sectors, most notably the industrial sector.

The completed development phases reflect the Zone's ability to achieve economic recovery on both sides of Omani-Yemeni borders In his interview with Duqm Economist Magazine, Al Balushi said that the area is operated and managed by the Public Establishment for Industrial Estates (Madayn) and has over the past years, worked on three phases of development that have contributed to proving the Zone's ability to achieve economic recovery on both sides of the Omani-Yemeni borders, where the Omani city of Al Mazunah and the Yemeni city of Shehn are located.

Al Balushi also stressed that the Zone, which marks the Gulf gateway to the transit trade to the Republic of Yemen and from there to the countries of East Africa, has been able, since inception in late 1999 as the first free zone in the Sultanate, to increase the intratrade traffic between the two countries. It also encourages Yemeni capital to invest in the Al Mazunah Free Zone, as it has created many opportunities for Omani investment for growth.

Three development phases

Said bin Abdullah Al Balushi said that the free zone in Al Mazunah, which covers an area of more than 15.3 million sqm, has witnessed a number of development phases. Initially, prior to the Royal Decree No. (2005/103) to establish a free zone in Al Mazunah and command its operation and development of services to Madayn, the industrial focus has been on the traffic of trade, import and export. However, post issuing the aforementioned Royal Decree, the Zone received more attention and Madayn began preparing plans for its development.

During the past years, 3 development phases were launched in which the infrastructure needed by the Zone was established to be able to attract investments such as internal road networks with lighting, construction of sidewalks, pedestrian paths, electricity, water and communications networks, water tanks, fire extinguishing systems, sanitation

services, and water drainage channels.

A rest building for truck drivers was also constructed during their layover in the Zone. Madayn is currently working on other projects there; among the most prominent is the services and facilities building project, which is being constructed with a total building area of more than 11,000 sqm.

Development agreements

The Director General of Al Mazunah Free Zone remarked that during the past years the Zone had signed 3 major development agreements. The first agreement was signed with the Hala Golden Trading and Contracting Company to develop 3 million sqm of the area. The second was agreed with the Logistic City Company to manage and operate the land port, while the third was with Shumookh Investment and Services Company aimed at constructing the mixed-use services building.

74 productive projects

He explained that, by the end of first quarter

of this year, the number of productive projects in the Zone reached 74 projects, most notably Al Mazunah water bottling factory, the paper tissue production factory, and the restaurant ovens production factory, noting that most of these projects are destined for export outside the Sultanate.

36 under construction projects

He commented that the number of projects under construction is 36, of which 13 are being established during the development phase of the Golden Hala Company, stressing that most of these projects are in the final stages of the construction process.

Economic gains

Said bin Abdullah Al Balushi, Director General of Al Mazunah Free Zone, touched on the economic gains achieved by the Zone. He also noted that the Zone has contributed to enhancing intra-trade between the Sultanate and Yemen, and promoting activities related to import and export, car showrooms, Implementing the fourth phase of development with an area of 4 million sqm comes within future plans

productive 74 projects in the Zone and 36 are under construction





contributed to boosting intratrade between the Sultanate and Yemen and created many opportunities for local capitals warehouses, and commercial agencies. This led to the establishment of many companies operating in the activities of import and export, customs clearance and handling.

In regards to crating job opportunities, he explained that the Zone has contributed to providing many job opportunities for the people of Al Mazunah. Around 1040 job opportunities have been provided by the projects operating in the Zone. In addition, the Zone also sponsors many activities and conducts training programmes for higher education students as part of their academic courses and graduation projects.

An invitation for investment

In his closing note, Said bin Abdullah Al Balushi, Director General of Al Mazunah Free Zone, stressed the invitation to investors from the Sultanate, Yemen, other Arab countries as well as international investors explore investment opportunities in the Zone. In view of this, Al Mazunah Free Zone enjoys a wide range of incentives and exemptions such as tax exemption for up to 30 years, customs exemption, and projects %100 ownership for non-Omanis, exemption from the minimum capital stipulated in the Companies Law, in addition to facilitating and simplifying procedures for non-GCC investors to obtain residency in the Sultanate.

The Zone is also characterised by special incentives such as easy access for Yemeni individuals, shoppers and investors without entry visas, and facilitating the work of the Yemeni workforce in the Zone without a work visa, in addition to it proximity to the Yemeni markets because they are located directly on the borders.

The Investors Services Department (One-Stop Shop) in Al Mazunah Free Zone provides all services related to the permits required for projects that are established in Al Mazunah Free Zone.

The One-Stop Shop was established according to the requirements of Article (1) of the Free Zones Law promulgated by the Royal Decree No. (2002/56) and the regulatory bylaw issued by Decision No. (2010/22) to establish a system through which all licenses, permits, approvals, and visas are issued and registration procedures are completed. As well, other procedures are completed through the same system, including registration of operating company and the implementation of all rules and regulations related to both the operating entity and the companies operating in accordance with the Free Zones Law.

Al Mazunah Free Zone Management is working with the Public Authority for Special Economic Zones and Free Zones (OPAZ) to implement the first phase of the unified system for One-Stop Shop, which includes SEZAD and the free zones in Sohar, Salalah and Al Mazunah.

The system aims to accelerate the completion of investors applications related to commercial registration and all permits required by investment projects and companies operating in the free zone in Al Mazunah. This comes according to the Royal Decree No. (2020/105), which stipulated the implementation of One-Stop Shop system in the special economic and free zones. Further, the Royal Decree granted OPAZ the powers to issue all types of licenses, approvals and certificates related to conducting economic activities in the these zones. The One-Stop Shop in Al Mazunah Free Zone strives to reduces efforts, cost and time, and simplifies procedures for companies operating in the Zone, so investors could only have one focal entity to obtain all services.

The Services Building built over 11,000 sqm

Al Mazyona Free Zone is currently witnessing the development of the mixed-use service building, which is constructed by Shumookh Investment and Services Company, at a cost of more than OMR 3 million. The building is built over an area of over 11,000 sqm.

The building, which is expected to be completed next year, brings all services and facilities required by investment operations in Al Mazunah Free Zone. It introduces these operations to investors, business owners, auditors and customers in one place. This will create an added value for the Zone that works on integrating services, speeding up the pace of business and facilitating procedures for completing transactions.

The project will be developed in two phases; the first phase includes 4 floors, while in the second phase two floors will be added according to the market's need at that time.

The building is located before the main gate of the Zone in a prime location that is easy to see, access and benefit from its services without the need to get inside the Zone. The project includes a multi-purpose hall, an office for the service centre - a path, restaurants, office spaces for import and export, and a free space for investment.

Since starting its operations on June 2020,21 until the end of last March, the land port in Al Mazunah Free Zone received over 540,000 tonnes of exports and imports, loaded on 35,000 trucks.

Faiz Awaidan Qumsit, Operations Supervisor at Al Mazunah Land Port, said, "The Port witnesses a daily active traffic. It receives an average of 100 trucks daily, while at peak times the number reaches 170. The Directorate General of Customs makes great efforts along with other government bodies, handling good inspection operations prior the importing or exporting companies obtain customs release data. The inspection process of each truck and delivering its customs declaration takes less than 30 minutes" He explained.

Faiz Qumsit is from the Wilayat of Al Mazunah and one of those who benefited from the job opportunities provided by Al Mazunah Free Zone. He joined the company after obtaining a Bachelor's degree in International Business Administration from the Netherlands.

Goods diversity

Qumsit said that the land port receives different goods like cars, fish, fruits and vegetables, and food and consumer goods. Exporting fish through the port is of high interest to importers and exporters, as more than 2,146 fish trucks carrying over 16,000 tonnes have been received, exporting fish outside Oman through the ports of Salalah, Sohar and other land ports. More than 2,000 truckloads of agricultural products of fruits and vegetables with a load of about 50,000 tonnes were received in the port.

One-Stop Shop services

The Company attends exporters and importers in the land port through One-Stop Shop, located in the customs yard. It serves customers and investors in the Zone in cooperation with the Directorate General of Customs, Al Mazunah Free Zone Management and other government bodies concerned with the release of shipments of foodstuffs, vegetables and fruits and food safety. Water bottling factory

Commenting on Al Mazunah Water Factory, Eng. Mohammed Jamal, Operations Manager at Manahel Al Saeed Company, said: "The Company has two production lines with a production capacity of about 6000 cartoons of water per day, branded as "Mazunah". The bottles of water are categorised into 4





different sizes that are 33ml, 600ml, 760ml and 1.5 liters, which are all very well-received by consumers".

The Operations Manager stressed on the Company's keenness to always ensure providing quality bottled water through the Company's water quality laboratories, as the produced water is examined regularly to comply with the Omani and GCC standard specifications.

"Most of the factory's products are promoted in the Republic of Yemen, while some products are directed to Al Mazunah markets and other Wilayats in Dhofar Governorate. The Company has a plan to increase its products in the Sultanate's markets during the coming period" stated the Operations Manager.

The lost prospects

It is very normal for free zones located on the borders of countries to be different from those located inside, as every scenario has its own setting. Places clearly indicate that there is a difference in the nature of business and the objectives between the free zones.

As well, there are other differences in a percentage of cases between free border zones - which are the focus of this article - from each other even if they are within the same country. This is attributed to the neighbor, who falls on this border differs from the one on the other boarder, unless the country has a one neighbor only, which is a rare case, of course.

All data indicate that a free border zone can only succeed if there is mutual need and sustainability that justifies the investment cost that will be spent between the two countries sharing boarders, clear cooperation, and open prospects for more areas of exchange. We all recall the obstacles that prevented the establishment of a free zone between Egypt and Palestine, close to Gaza due to the unfortunate disagreement between Palestinians. However, all objective reasons that require its establishment and all the success factors are available.

It is also noteworthy that most of the free zones over the boarders, across the whole world, are mainly commercial, and are based on storage, warehouses, car showrooms or equipment, and logistics. Perhaps, there are some other simple manufacturing operations, not the industrial ones of course; such as sorting, packaging and canning. Such a free zone is could only be industrial if it enjoys a unique geographical location with very competitive advantages on one side or both sides of the zone.

As a theoretical example that if there is a mining industry on one side or having on the opposite side directly the possibility to establish manufacturing business for raw materials from which new products could be manufactured instead of transporting raw material or even making new investments to manage manufacturing it.

It is also noted that one of the most important success factors for the free zones is that being located close to a port or an airport and to be linked to a strong transport network or even a single strategic road. Al Mazunah Free Zone stands a good example here, since its inception in 1999 between the Sultanate of Oman and Yemen.

The interesting thing is that the one might attribute the strong trade activity in Al Mazunah to the deadly war taking place in Yemen and the consequent increase in the needs of Yemenis for food, medicine, clothing, building materials, cars and in return their demand to import or export their agriculture and fish products overseas through Port of Salalah by Al Mazunah.

In addition, all international relief organisations are in need to offload aids in Salalah and then transport it to Yemen via Al Mazunah to be delivered to Yemen and distributed across the country there.

Moreover, one might think that Al Mazunah is just a temporary zone due to the crisis, which is totally not true. The history of its inception itself proves that, and in fact that Al Mazunah is a significant focal point to both countries, serving intra-regional trade and Yemeni trade to oversees on the other hand. I believe that it will take a long time before any party thinks about trying to build a different geographical equation through human action to change this reality, with its mountains and desert and in its complex relationship with the sea. Al Mazunah is more than 260 km far from the Port of Salalah.

The same is true for shipping as it is located in the upper northeast of Yemen, and far from the sea, and there is no indication that this distance can be challenged or linked to a Yemeni port that is closer than the Port of Salalah.

Assuming that Yemen could witness an extensive reconstruction and establishment of infrastructure, but we have not heard of any plans for establishing Yemeni ports close to the sea and heading to the Sultanate of Oman to be as an alternative to Al Mazunah or even compete with it.

However, it is only possible if the traditional Yemeni ports came back. This could only affect Al Mazunah in some aspects, but it opens other horizons for Al Mazunah because the condition of Yemen, its people, their production, consumption and trade at the time will be much better, and this will strengthen the status of Al Mazunah in the business of shipping.



Considered among the five most endangered groups **Rescuing a Humpback** Whale near the Port of Duqm

The International Whaling Commission (IWC) commended the Sultanate's efforts in rescuing a Humpback Whale, which was caught in fishing nets near the Port of Duqm, on January 19.

The Environment Authority explained that on January 21 ,2021, a15-mtr-long Humpback Whale was freed from the nets, praising the efforts made by the Authority's specialists and experts of the Five Oceans Company, along with the support of Duqm Port, Coast Guard and Royal Air Force of Oman. The Authority commented on a twitter post, "Based on the reported observation that the Humpback Whale was released from the trapped nets, the team announces the successful completion of the rescue mission".

The Authority noted that Royal Air Force of Oman flew the Casa planes to track that the whale left to the ocean safely, while Coast Guard monitored the path of the whale as it crossed the waters of Duqm Port.

An important rescue operation

The International Whaling Commission (IWC) reported that having the Humpback Whale in the Arabian Sea is unique; it is the only group of such kind of species that does not migrate. Rather, it spends lifetime in the Arabian Sea, which makes it seriously endangered. Thus, the rescue operation carried out by the Environment Authority with other partners is of a great importance indeed.

IWC clarified that the Scientific Committee of the International Whaling Commission has classified the Humpback Whale in the Arabian Sea from the five most endangered groups. Therefore, rescuing only one whale marks a significant impact on genetic diversity and inhabitants' restoration of this whale type. Further, IWC confirmed that the Sultanate's Government has succeeded in responding to the emergency and other incidents that threaten the marine environment.

This type of whales is called the "Humpback Whale" or camel of the sea. It belongs to the jumping whales' family, having a short body, large head and its dorsal fin is relatively small. This black colour whale is around 12 to 16 metres long and the female often gives birth to two in one abdomen, and its length at maturity reaches 51 foot. International Whaling Commission (IWC): Rescuing only one whale has a major impact on genetic diversity and inhabitants' restoration.

Eng. Mahmood Al Hinai stands every morning on the ground of the multi-purpose Fishing Port in Duqm to observe the progress being made in the Port's construction works, which reached final stages by early March 2021.

Mahmood, a Graduate of BA in Civil Engineering from Caledonian College of Engineering in Muscat in 2014, did not expect to live in Duqm someday. Neither he imagined to be responsible for supervising a project as big as the largest fishing port in the Sultanate. Commenting on this experience, he said that the project was an opportunity to get firsthand experience about the construction works of ports, roads and their operation. As well, he could learn a lot in the field of maritime works in ports, within and outside the Sultanate through the field visits conducted to different ports.

Building Omani expertise in port supervision is one of the achieved gains

> "The Port is considered an integrated project, so supervising it marks an opportunity to develop the skills of engineers. The project includes many marine works such as fixed and floating berths, breakwaters, and drilling operations to deepen the Port's basin, in addition to road works that connect the Port with the Fishing Industries Zone. Other works in the Port are the surface water drainage from the canals and control of valley water within the Port area. Moreover, there are infrastructure works such as leveling and reclamation of land for the construction of service buildings and using them in the process of managing and operating the Port", Al Hinai explained.

Prior to joining this project, Eng. Mahmood Al Hinai worked in a number of other

departments in the Oman Company for the Development of the Special Economic Zone at Duqm "Tatweer Duqm", through which he gained experience that helped him in his new mission to supervise the Fishing Port project.

Important events

The Port witnessed two important events, the first was in 2019 when the Special Economic Zone Authority at Duqm (canceled by the Royal Decree No. (105/2020) decided to increase the depth of the Port from 6 to 10 metres. This decision came in order to increase its economic value and prepare it to attract large fishing vessels operating on big seas. The second event is the decision of the Public Authority for Special Economic Zones and Free Zones - which replaced the previous authority- to conduct a study to convert the Fishing Port of Dugm into a multi-purpose port. Hence, it will provide facilities for handling foodstuff related to fish activities and transforming the Fishing





Industries Complex, located near the Port, into a complex for food industries, including the fishery industries.

Eng. Mahmood Al Hinai - who took over the task of overseeing the Port in 2018 after obtaining a master's degree in Engineering Management from Aston University in the UK - witnessed these two events and considers them today as the Port has reached its final stages, two key milestones in his career journey.

Building Omani expertise

Mahmood Al Hinai confirmed that he has gained a good experience and enriched his knowledge in this sector. The other fellow Omani engineers working for consultation firms confirm the same too. They regard that building Omani expertise in the field of port supervision and related infrastructure is one of the gains that were achieved by the multipurpose Fishing Port.

Happy to work on the project

Mazin bin Nasser Al Sulaimi is a Mechanical Engineer working for the Italian company, Sering, which provides consultation services for the marine works project for the Fishing Port. He is one of the first engineers who worked on the project since the initial construction works in 2016. Over these years, he witnessed many works that have been carried out at sea and on ground. When he recalled his memories of the first months he spent in Duqm, he commented that he was happy to work on the project, and in many cases he would spend his weekend in Duqm. Mazin works as an inspector on concrete and other cement works, which are considered a

major part of the project. He witnessed many works that are made around the clock in the casting yard. "I've often worked at night in this yard, where the place is full of life, turning like a beehive with a big number of workers at night", commented Mazin.

Quality control

According to Mazin, this yard accommodates more than 25,000 pieces of Cor-Locs, which are used as supports in the breakwater with other huge concrete bricks were poured. Mazin stands among the employees performing his role as an inspector of the quality of work carried out in this yard. "We are keen to ensure that the work is done in accordance with the maps and specifications approved for the Fishing Port", remarked Mazin. After that, Mazin worked on other engineering works at the Port, including quality control of casting operations at the quay and installing breakwaters.

New experience

Ahmed bin Mohammed Al Ajmi shares with us another rich experience. Post his experience of working on the intersections project on the Al Batinah Road, he moved in 2017 to Duqm and started another chapter of his career journey with different challenges at the Fishing Port of Duqm, located on the Arabian Sea and the Indian Ocean.

Amidst these challenges, Ahmed started working as a project engineer for the first time since he started his job as a civil engineer at the Italian company, Sering. The new role requires more scrutiny on the quality of the materials used in the port roads, such as soil, cement and iron. After two years of working on this project, Eng. Ahmed Al Ajmi confirms that he has benefited a lot in the field of discovering the strength or weakness of the soil as well as how to deal with its problems, with climate changes and wind intensity.

"Working on the marine works project for the Port of Duqm is very rewarding experience for engineers. The project includes marine works related to construction of breakwaters and berths and deepening the Port depth as well as other works on land such as building roads, drainage works and other works. Likewise, we gained a lot from the foreign expertise of our colleagues from Italy and Greek", said Ahmed Al Ajmi.



Duqm Airport welcomed 25,000 passengers in 2020

Duqm - Dugm :

The total number of passengers traveling through Duqm Airport in 2020 reached about 25,000, compared to over 58,000 in 2019.

Since its inception in 2014, Duqm Airport has served the traffic of aircraft and passengers between Muscat and Duqm airports. The number of flights operated by Oman Air between both airports is six (6) daily flights per week, except for Friday.

Last year witnessed a decrease in number of flights between Muscat and Duqm airports, which reached 328 flights only. This is attributed to the Covid19- pandemic, which had an impact on airlines traffic in most countries worldwide.

February marks best records

The total number of passengers arrived at Duqm Airport last year was 12,754 passengers, with around 12,051 passengers departured from Duqm.

The month of February recorded the highest

rate of passengers in 2020, as the number of arrivals to Duqm Airport reached 3048 and departures were 2563 passengers. However, the Airport stopped receiving passengers for almost 5 months, starting from April to August. The Airport resumed receiving flights in September, with around 258 passengers arrived, flying from Muscat in (8) flights.

Duqm Airport is regarded a key growth back up for the Special Economic Zone at Duqm (SEZAD), given that it connects the Zone with other countries around the world, while it is ready to receive international flights.

The Airport consists of passengers' terminal with a capacity to receive half a million passengers annually and could be expanded to receive two million passengers annually in the future. It also includes the air cargo building with a capacity of 25,000 tonnes per year, with the possibility of expanding according to future demand.

As well, the Airport brings a 4-km runway with 75 metres wide, with connecting corridors and parking spaces for four aircrafts, including the Airbus A380.

Through this Group, we are intending to promote Discover Duqm Campaign. We have already equipped the hotel with the wind station, which demonstrates the measures bar of temperatures as well as winds' speed and direction", explained Michael.

"This service is being introduced based on pre-booking through the hotel, but the specialised business Group is operating it in our premises. As summer is the perfect season for wind surfing, we are targeting to attract watersports community to experience their favourite sport in Duqm", he added.

The ceremony was held in Muscat City Center, Seeb under the patronage of HE Eng. Ahmed bin Hassan Al Dheeb, Deputy Chairman of the Public Authority for Special Economic Zones and Free Zones (OPAZ).

Sadiq bin Jaffer Sulaiman, CEO of Maysan Properties, said: "The construction works for the first phase will start in late April 2021, with expected completion to be in Q4 of 2022.

A successful marketing campaign

In an interview with Duqm Economist Magazine, the CEO described the marketing campaign, organised in Muscat and Duqm, as very successful. "Despite the impacts of the pandemic, we observed a good turnout with serious reservations and more are expected in the coming months. The Company is planning to promote the project in other GCC countries

by end of this year. With this approach, we will promote Duqm as a promising investment destination for GCC investors, with various investment opportunities and incentives, moderate climate in the Zone and available infrastructure", He explained.

Project's components

The first phase of Maysan Square Duqm includes an office complex consisting of 3 pavilions with 229 commercial freehold units and retail stores, released based on usufruct system for a period of 50 years, which can be extended for similar period. The complex will be built over 12,000 sqm of land with a built up area covering 30,000 sqm. The project is strategically located at the centre of Duqm, with around 10 minutes far from Duqm Port and 15 minutes away from Duqm Airport.

Prices

The offices prices range between OMR 27,000 – OMR 50,000, according to the unit size, varying between 45 sqm - 75 sqm. The project will be equipped with protection systems, central air-conditioning and smart management of parking lots and waste. Offices could be furnished based on customers' request. "The prices set by the Company for offices are of good returns on investment, which are also lower than the prices of



similar projects. When compared with a similar project, we will find that our prices are the best, and the return on investment in Duqm is higher than many other locations, including Muscat. SEZAD has been witnessing for several years a high demand for offices, residential apartments and hotel rooms. This made the employment rate in the real estate sector in Duqm high, which leads to providing good investment opportunities for local and foreign companies and individuals wishing to invest in the sector", The CEO commented.

OPAZ issues controls of environmental permits in special economic zones and free zones

The decision aims to apply high standards of environment preservation in all projects developed at special economic zones and free zones

HE Dr. Ali bin Masoud Al Sunaidy, Chairman of the Public Authority for Special Economic Zones and Free Zones (OPAZ), issued a decision regulating the controls for organising and issuing environmental permits in the special economic zones and free zones in the Sultanate.

Lubna bint Hamoud Al Sabari, Environmental Specialist at the Public Authority for Special Economic Zones and Free Zones, pointed out, "The decision applies to all projects developed in the special economic zones and free zones. It specified the procedures for obtaining environmental permits and identified the projects that require preparing a detailed environmental assessment study for their potential impacts". Projects are

classified into 3 categories based on their impacts to the environment and health of human beings

Classifying projects to 3 categories

According to the decision, the projects established in the special economic and free zones have been classified into three (3) categories based on their impacts to the environment and health of human beings, their nature, location, materials used in production and production capacity. The First Category includes high-risk projects, as identified in Annex No (1).

These projects are required to submit an environmental and social impacts assessment study. Projects of this category include those related to the development and management of industrial plans, logistics storage sites, fishing ports and fish industries complexes, tourist villages with an area of 10 hectares or more, chemicals and oil storage tanks of around 5 hectares and more, heavy industries, oil refineries, chemical and petrochemical industries. power plants, seawater desalination plants with a production capacity of over one million cubic metres per year, and fish farming projects with a production capacity of more than 500 tonnes per year

for the localised fish and any quantity of abnormal species.

The Second Category includes projects with medium environmental risk, which require submitting environmental management plan. However, the Third Category is for projects with low environmental risk, requiring compliance with the specified general and technical environmental requirements, while submitting an environmental and social



impact assessment study or an environmental management plan is not required.

Facilitating procedures for investors

Lubna Al Sabari, stated, "OPAZ is intending to facilitate the procedures for investors and accelerate issuing environmental permits. For instance, the environmental permits for projects falling into second and third categories are issued prior establishing projects. These permits will be issued in (5) working days for third category projects and (10) days for the second category. However, for the projects that require an environmental assessment study, it takes a maximum of thirty (30) days for reviewing the environmental permit applications. This process serves to avoid the negative impacts of projects, which require a thorough evaluation before granting the environmental permit".

Categorising chemicals

The Environmental Regulatory Department shall categorise chemicals based on international classifications, including the global system for classification and labeling of chemicals. It also develops guidelines for all phases of the chemicals safe management procedures and compiles an inventory of banned and restricted chemicals and those dealing with these chemicals. Moreover, the Department collects information about conditions of using, transporting, storing, handling and disposing chemicals.

"Projects must register the hazardous materials used, manufactured or produced as waste with the Department. As well, projects shall obtain the necessary permits to deal with chemicals as per the defined legal standards and controls and the procedures of Basel Convention. Further, projects shall provide the Department with information, maps and plans of sites allocated for storing and using radioactive materials, which are approved by the concerned authorities", Lubna Al Sabari explained.

She also stressed that the new decision prohibits the import or export of hazardous materials and any hazardous waste listed in the Basel Convention without obtaining a permit from OPAZ.
