| 2. | Reference is made to the Sleeper beam SB3 at horizontal loops. A discrepancy was noticed regarding the dimensions of the aforementioned beam.  Item E of section 3 of Appendix D states that the dimension of the beam shall be 600x1500x10500mm whereas the provided drawings illustrate a beam dimension of 600x1500x14300mm, please clarify. | Delete 600x1500x10500mm from Item (e) of section 3 of Appendix D and replace with 600x1500x14300mm |

Reference to Query No. 1 on Circular No. 7

"The contractor responsibility is to design the power supply up to the northern boundary of the corridor ...." And referring to Query No. 4 on Circular No. 3"...Neither a temporary or a permanent fence will be constructed in the Wadi area". It is clear that there will be 3 contiguous segments of the fence separated by the wadi and channel 5-1 which are not fenced while there is only one power source for the lighting at the north end of the corridor.

- 1. Please confirm that power supply cables to the lighting of the fence segments south of channel 5-1 and between channel 5-1 and the Wadi can be run above ground on or above the pipe sleepers and that this will not be in conflict with the Duqm Refinery requirements due to the proximity of the power cables to the pipes.
  - 2. Please provide the fence lighting performance specifications or design requirements (illumination levels, controls requirements, light fixtures and cabling specifications)

1.All power cables shall be laid in conduits below ground as per the length between SP1 to SP5. Except across the wadis where they might be laid inside conduits suspended from the pipe supports.

The Contractor shall provide a design to ensure that the areas is appropriately illuminated and demonstrate it complies with to best practice
