# INVITATION TO PRE-QUALIFY FOR MAJOR ENGINEERING, PROCUREMENT AND CONSTRUCTION WORKS OF THE NEW BULK LIQUID BERTHS TERMINAL IN PORT OF DUQM, SULTANATE OF OMAN

## INTRODUCTION

The Special Economic Zone Authority at Duqm (SEZAD) is seeking to engage an Engineering Procurement and Construction (EPC) Contractor to carry out the Detailed Design (based on owner provided FEED), Procurement and Construction works for the new bulk liquid berths terminal in the Port of Duqm, Sultanate of Oman.

The Invitation to Tender (ITT) is targeted to be issued to Pre-Qualified companies in Q2, 2015 with award of the EPC Contract. Commencement of the work is planned in Q4, 2015 with Terminal handover scheduled for Q4, 2018. The Terminal will be the outgo port for the proposed Duqm Refinery which will be built adjacent to the Terminal and accordingly, construction of the Terminal will be schedule-driven.

SEZAD is seeking to prequalify prospective tenderers for the EPC Contract.

Applicants are invited to obtain the Project Pregualification Questionnaire.

### SCOPE OF WORK

The Project Prequalification Questionnaire provides a description of the scope of the work, which includes the following major work packages:

- 1. Dredging and Reclamation;
- 2. Jetty Structure; and
- 3. Topsides Facilities including product storage tanks, dry bulk facilities, pipelines, buildings and roads, etc.

### PRE- QUALIFICATION ASSESSMENT

The prequalification of tenderers will be based upon previous track record of satisfactory work, taking into account maritime and liquid berth jetty and pipeline and storage tank terminal design and construction experience in the region and internationally, organizational structure, quality management, HSSE systems, and financial status. The ITT will include the form of EPC Contract providing for single point responsibility for performance of the entire work scope. Due to the multi-disciplinary nature of the work scope, major subcontractors and joint venture corporations will be considered for pre-qualification.
